6. Reports

- i) Treasurer's report
 - a. Cash at bank is approximately \$36k
 - i. Profit for Aug 2025 ~\$11k
 - b. Good profit from the Commonwealth Carnival
 - i. Carnival profit pre grant is ~\$9k
 - 1. Grant is \$10k first \$8k already approved by Gov't
 - ii. Should we have a mid-year shoot to increase revenue?
 - 1. It was generally thought a mid-year would be beneficial to the Association's finances
 - c. School shoot returned profits of ~\$900 for practice and ~\$600 on canteen
 - i. All targets already expensed
 - d. Approximately 3-4 pallets of La Porte remain sell or use?
 - i. General consensus was to use Green Dream for ISSF
 - 1. Probably not enough targets in stock for ISSF Nationals
 - ii. Use for EOY ISSF test event
 - iii. Perhaps sell Laporte to Melbourne Gun Club? Treasurer to follow up
 - iv. Carry over to next meeting
 - e. ACTA loan
 - i. The question of paying the loan out early was raised
 - 1. The consensus was pay after the carnival, as due
 - 2. Interest is at bank swap bill rate
 - f. Some notes on financials:
 - i. YTD profit ~\$12k
 - ii. Minimal creditors and debtors
 - 1. Mostly school shoot ammo
 - iii. Targets are now expensed per event not annually
 - iv. ACTA have repaid the Waveform invoices ~\$10k
 - v. ACTA to pay Container costs
 - 1. Need confirmation in writing Treasurer
 - vi. Stock on hand is Green Dream targets ~ \$4.5k
 - vii. Echuca has reneged on paying Trevor Dehne's trap repair invoice

- 1. ECTC claims it was for splitter adjustment, not maintenance
- 2. T Dehne to supply revised invoice

viii. ISSF Nationals

- 1. VCTA will charge a target and ground fee
- 2. ACTA takes nom's etc.
- 3. Shoot Aus to supply officials
- 4. Treasurer to discuss with ACTA

ii) ACTA report – Presidents' meeting

- a. ACTA expected to update membership system to day of joining anniversary, mid 2026
- b. ACTA saving ~\$100k pa by self-insuring firearms cover
 - i. It was suggested that the current ACTA limit was too low, many guns are worth more
- c. Review of National Championships rotation between WA and QLD, whether to continue
 - i. The general feeling was that Roma should remain. However, due to the WA expense and firearms laws, this destination may no longer be viable
- d. MCMS under review states to submit thoughts
- e. National Balltrap will be held over 3 layouts during the National Carnival
- f. Commonwealth
 - i. review time of year
 - ii. whether to continue with 18m
 - iii. should it lead into a state carnival
- g. Referee stands at Wagga now have shade sails
- h. HoF discussion regarding female induction criteria
- i. Sen Vet Masters reclassification for National events to ensure National and International competitions align
- j. States to be informed of ACTA news before released publicly
- k. Next ACTA Presidents' meeting to be in December

iii) Committee of Management - JP

- a. Solar panels on shed were discussed quotes flowing
- b. EPA Container noise abatement works discussed required items:
 - i. Landscaping to support the containers crushed concrete
 - 1. A second quote must be sought prior to approval
 - ii. 6 x 40' HC containers
 - iii. Painted
 - iv. Containers to be positioned along road, behind trees
 - v. Containers not to be used primarily for storage only if ad hoc use required
 - vi. Works must be completed by Dec 31, 2025
- c. Shed roller door was damaged requiring repairs of ~\$600
 - i. Door failure was when the President was on site
- d. Broken strut from trap lid replaced
- e. VCTA office cabinets
 - i. Only VCTA to have access N Dean to return his keys
 - 1. Should a shared item be required when no VCTA person on site, VCTA will then have to attend
- f. Rubbish ECTC and VCTA to pay their own rubbish removal VCTA to no longer subsidise ECTC with this
- g. A January shoot to be held for EPA acoustic testing

- i. Ensure this does not clash with the ISSF Nationals
- h. Letter of solidarity
 - i. A letter to be published to the shooting public stating that VCTA and ECTC are working in harmony.
 - 1. This is to dispel rumours
 - ii. To be shared with ECTC before publishing
 - iii. T Williams noted that ECTC members may be subject to SAPA investigations and thus a letter would not be appropriate.
 - iv. It was noted that it is not a personality issue, it is the two entities of VCTA and ECTC that must work together
 - v. B Davis noted that this was supposed to refer to EPA issues only.
 - vi. The secretary reminded everyone that such an article had already been published in the recent CTSN. This probably has already covered the requirement. The article circulated to all during the meeting
 - vii. A question was asked as to why this letter was required. JP noted this was primarily to dispel rumours of the state grounds closing due to EPA issues etc,.

<u>MOTION</u>: That a letter be drafted and published to confirm that the VCTA and the ECTC continue to work in harmony, now and into the future, for the betterment of the sport.

Moved: J Patterson Seconded: D Cleary CARRIED

- i. Grounds person tenancy Work Cover etc
 - i. The secretary noted that he had spoken to regarding the volunteer worker insurance option. It was discussed that secretary is basically an employee. performing ground maintenance duties and received free rent as a 'contra' deal.
 - It was agreed that the risk upon the VCTA and its members of some type of work injury claim is unacceptable
 - 2. VCTA and ECTC could officially employ and share the Workcover cost
 - a. This is an issue because should a claim occur, we would be paying this for years
 - 3. It was noted this has been discussed multiple times, still no solution
 - ii. Is the dwelling itself habitable?
 - 1. It was noted the lease only has ECTC and on it, VCTA not a signatory
 - iii. Will Echuca agree?
 - iv. Very few options available JP and CL to meet via video meeting to discuss termination of the tenancy agreement, and the points below, with ECTC within the next two weeks:
 - stop using the cottage
 - 2. remove the side dwelling
 - 3. Find a new contractor
- j. Trap 4 is getting 'tired'. swap trap 1 into trap 4.
 - i. Trap 4 is continental
 - Trap houses not quite compliant with continental traps
 - 2. Use standard traps in 3 and 4 to give shooters a better target presentation
 - 3. Perhaps put the continental traps into practice grounds
- k. ECTC claims ownership of the Kawasaki buggy and does not want the VCTA to use it any more
 - i. Do we need mediation to resolve?

- ii. The secretary is of the belief that this is covered in the Deed of Co Ownership 2.2 (a):
 - "To the extent that any Chattels are located at the Land, the parties agree that the party that purchases such Chattels is to retain ownership of such Chattels and to the extent that both parties contribute to the purchase price of any Chattels, the parties will own such Chattels in proportions equivalent to their respective contributions to the purchase price."
- I. Property valuation
 - i. Do we get an outside valuation or use rate notice?
 - 1. Wait for rates notice form ECTC
- iv) Zone Reports
