Meeting Minutes

Meeting held at Online Wednesday, 06th August, 2025

- 1. Chairperson to open meeting and welcome all in attendance. Meeting opened at 19:05

Apologies: None [Note: Stephen Trembath and Mark Coleman resigned after both ACTA and legal opinion found Mark's motion at the previous was deemed to be inconsistent with the rules and was declared null and void]

- 3. Minutes Of Previous Meeting
 - a) Tuesday, 08 July, 2025

The president addressed the meeting and reminded the Executive that due to the noncompliant motion of the previous meeting, motions subsequent to the non-compliant motions must be revisited.

The president also congratulated Allan Kidd upon his election as NEW President.

- 6. Business arising from the Minutes. Business arising from the Minutes.
 - a. Commonwealth carnival to be covered later
 - b. ECTC A Kidd
 - i. Letter sent back to ECTC VCTA no jurisdiction. ECTA to take further action if they wish
 - ii. SAPA investigation all complaints, emails etc., re bullying and harassment to be sent through to the ACTA
 - c. Survey results
 - i. J Patterson has provided the winner's bank details [Darcy Mans]
 - d. Schools Terms of entry/guidelines
 - i. M Coleman has sent through proposed guidelines will be for 2026
 - ii. B Davis noted they had run the SEZ School Shoot, only 87 attendees. Lower than expected Ammunition
 - iii. General discussion about school shoots ensued, dates etc.
 - iv. It was noted the NEZ school shoot will coincide with the commonwealth carnival practice.
 - v. It was further noted that ECTC I shaving a corporate/school shoot on the same day.
 - e. Echuca Cottage
 - i. Waiting for next CoM meeting during Commonwealth Carnival
 - ii. Rubbish, cleaning etc to be discussed at the next CoM meeting
 - iii. Are there any CoM meting minutes? JP stated yes, and he will forward to the secretary
 - iv. TW noted the CoM should have a firm framework, number of members etc.
 - v. Who will replace M Coleman on the CoM? Currently only JP and CL are on it.
 - vi. It was noted that the VCTA representatives on the CoM are a sub-committee of the VCTA and thus cannot act without the approval of the entire VCTA Executive no arbitrary decisions
 - vii. ECTC are yet to reply with their list of solely owned chattels
 - f. Constitution review
 - i. Ongoing proposed legal costs from CPR ~\$3,000 for constitution review + \$2,500 for advice on a new constitution
 - ii. Look for grant re constitution development Vicsport?
 - iii. It was noted the new constitution must comply with CAV requirements
 - iv. A Kidd requested a draft be circulated at the soonest
 - v. K Thompson noted the task is large and would welcome input from ACTA and others, J Patterson noted that he had sought advice from the ACTA and other states
 - vi. B Davis asked how far along the draft was. K Thompson noted she had not been consulted, that M Coleman had already drafted it. However, KT noted the current zone election system was retained and this was probably not the best way forward.
 - vii. A short discussion was held regarding the method of electing Executive Members a direct election by the clubs, not zones, was canvassed: as per ACTA method and had support. JP noted he was developing a direct election style board.
 - viii. Ultimately, it as conceded the constitutional review would not be ready for the 2025 AGM and more work to be done.

- h. T Williams Complaint nothing to add, being sent to SAPA
- i. CoM Removal of alarm codes
 - i. It was resolved the lockers should be VCTA only, no ECTC access required

 no real value.
